An ordinance levying taxes for all town purposes for **Oswego** Township,

**Kendall** County, Illinois, for the tax year 2019 , collectable in 2020.

BE IT ORDAINED by the Board of Trustees of **Oswego** Township,

**Kendall** County, Illinois, as follows:

SECTION 1: That the sum of

**One Million One Hundred Four Thousand Two-Hundred Sixty Nine and 00/100 Dollars**

**(\$ 1,104,269.00)** are hereby levied upon all

property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted

by the people in accordance with the law, for such purposes as:

**GENERAL ASSISTANCE**

**CEMETERY**

SECTION 2: That the amount levied for each object and purpose shall be as follows:

SECTION 5: That this ordinance shall be in full force and effect after its adoption, as provided by law.

**TRUTH IN TAXATION  
CERTIFICATE OF COMPLIANCE**  
(35 ILCS 200/18-90)

I, the undersigned, hereby certify that I am the presiding officer of Oswego Township, and as such presiding officer I certify that the levy ordinance, a copy of which is attached, was adopted pursuant to, and in all respects in compliance with the provisions of Sections 18-60 through 18-85 of the "Truth in Taxation" law.
