An ordinance levying taxes for all road purposes for Oswego Township Road District Kendall County, Illinois, for the tax year 2021, collectable in 2022.

BE IT ORDAINED by the Board of Trustees of Oswego Township,
Kendall County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of Oswego Township Road District on December 14th, 2021 does hereby determine and declare that the sum of

Two Million Six Hundred Thirty Thousand, Four Hundred Eight Dollars (\$2,630,408.00) are hereby levied

upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as:

- General Road and Bridge Fund,
- Permanent Road Fund
- Equipment and Building Fund

for the tax year 2021.

SECTION 2: That the amount levied for each object and purpose shall be as follows:

SECTION 4: That the Board of Trustees does hereby certify that the amount levied herein is necessary to be raised by taxation for road purposes for Oswego Township Road District.



SECTION 6: That this ordinance shall be in full force and effect after its adoption, as provided by law.




