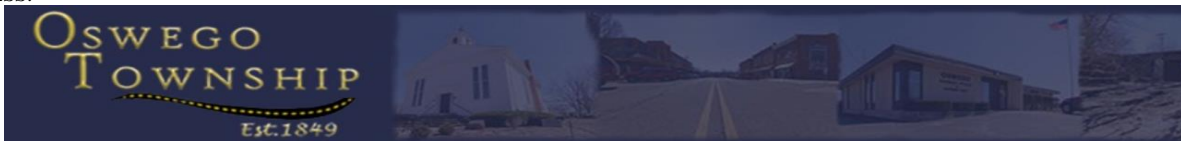

NOTICE OF SPECIAL TOWNSHIP MEETING OF ELECTORS OF OSWEGO TOWNSHIP. Notice is hereby given that the Oswego Township Board will hold a Special Township Meeting of Electors on January 11, 2022 at 7:00 p.m. at 99 Boulder Hill Pass Montgomery, IL 60538 for the electors to consider and act on conveying the Township right-of-way located on Douglas Road, south of Wolf Road pursuant to a Dedication that is dated July 26, 2001 with a Plat of Survey which was recorded on July 30, 2001 as Document No. 200100013677, Illinois to the Village of Oswego and which is legally described as follows:

THAT PART OF THE NORTHWEST QUARTER OF SECTION 15, TOWNSHIP 37 NORTH, RANGE 8 EAST OF THE THIRD PRINCIPAL MERIDIAN DESCRIBED AS FOLLOWS:

BEGINNING AT THE INTERSECTION OF THE CENTERLINES OF DOUGLAS ROAD AND WOLF'S CROSSING ROAD: THENCE NORTH 84 DEGREES 16 MINUTES 53 SECONDS EAST (ILLINOIS STATE PLANE GRID – EAST ZONE), COINCIDENT WITH THE CENTERLINE OF WOLF'S CROSSING ROAD, A DISTANCE OF 40.05 FEET; THENCE SOUTH 02 DEGREES 49 MINUTES 30 SECONDS EAST A DISTANCE OF 1486.03 FEET TO THE SOUTH LINE OF SAID NORTHWEST QUARTER OF SECTION 15; THENCE SOUTH 88 DEGREES 47 MINUTES 30 SECONDS WEST A DISTANCE OF 438.29 FEET; THENCE NORTH 87 DEGREES 10 MINUTES 30 SECONDS EAST A DISTANCE OF 40.00 FEET; THENCE NORTH 02 DEGREES 49 MINUTES 30 SECONDS WEST A DISTANCE OF 1043.47 FEET TO THE POINT OF BEGINNING, SAID DESCRIBED PROPERTY LYING IN KENDALL COUNTY, ILLINOIS, CONTAINING 1.7661 ACRES, MORE OR LESS.

BEGINNING AT THE INTERSECTION OF THE CENTERLINES OF DOUGLAS ROAD AND WOLF'S CROSSING ROAD: THENCE NORTH 84 DEGREES 16 MINUTES 53 SECONDS EAST (ILLINOIS STATE PLANE GRID – EAST ZONE), COINCIDENT WITH THE CENTERLINE OF WOLF'S CROSSING ROAD, A DISTANCE OF 40.05 FEET; THENCE SOUTH 02 DEGREES 49 MINUTES 30 SECONDS EAST A DISTANCE OF 1486.03 FEET TO THE SOUTH LINE OF SAID NORTHWEST QUARTER OF SECTION 15; THENCE SOUTH 88 DEGREES 47 MINUTES 30 SECONDS WEST A DISTANCE OF 438.29 FEET; THENCE NORTH 87 DEGREES 10 MINUTES 30 SECONDS EAST A DISTANCE OF 40.00 FEET; THENCE NORTH 02 DEGREES 49 MINUTES 30 SECONDS WEST A DISTANCE OF 1043.47 FEET TO THE POINT OF BEGINNING, SAID DESCRIBED PROPERTY LYING IN KENDALL COUNTY, ILLINOIS, CONTAINING 1.7661 ACRES, MORE OR LESS.
