 - a. Effective 11/1/22 we will implement an Emergency Assistance Program. Maximum funding for 2022 will be \$20,000.00. Max. Payout per household to be \$900, no more than once every 18 months and twice within a 5-year period.
 - b. Effective 11/1/22, the General Assistance Grant will increase from \$332 per month to \$664 per month maximum. Cases with one child only will remain at \$332. Nonexempt Asset disregards will be set at: \$1000 for both adult cases and 1 child 1 adult cases. \$500 for a Case with one child only. Disregards will increase \$75 for each additional child in any case structure.
