

Minutes of the Oswego Township

REGULAR MEETING

January 10, 2023

APPROVED 2-14-2023

The meeting of the Oswego Township was called to order at 6:30 PM by Clerk Ken Holmstrom in the absence of Supervisor Joe West. The meeting was held at 99 Boulder Hill Pass, Montgomery, Illinois. The pledge of allegiance to the U.S flag was given by all in attendance.

Township officials in attendance in person were, Clerk Ken Holmstrom, Trustees Bush, Jacobsen, Sawicki and Selmer. Highway Commissioner Ainsworth, Donna Stanley, Rob Delong and Bill Helgeson were present. Attorney Keri-Lyn was present. Deputy Briars was present. Clerk Holmstrom mentioned that a quorum was present in person. Five other residents were present. Supervisor West and Assessor Hauser were absent.

Clerk Holmstrom asked for a motion to appoint a temporary Chairperson for the meeting. Trustee Jacobsen motioned to appoint Trustee Sawicki as Chair for this meeting. Trustee Selmer seconded the motion. Roll call: Trustees Bush, Jacobsen, Sawicki and Selmer voted to approve. Clerk Holmstrom turned the meeting over to Trustee Sawicki.

Trustee Sawicki asked if there were any corrections to the Minutes from 12-13-2022. Trustee Selmer motioned to approve the minutes of 12-13-2022, second by Trustee Bush. Roll call: Trustee Bush, Jacobsen, Sawicki, and Selmer voted to approve.

Kendall County Sheriff reported that the recent shooting in Boulder Hill was an isolated incident. The incident is still under investigation.

Trustee Report: Trustee Bush gave her report on Senior services with number of seniors that took advantage of the services offered. She next stated that she has reviewed bank reconciliations through 12-31-2022.

Trustee Jacobsen – No Report.

Trustee Sawicki – She stated that the senior center is also there to help the youth in the Oswego Area and she is looking into some possible programs that may be offered at the Community center location.

Trustee Selmer – Attended the Cemetery Board meeting. She talked about a call she received from a resident on mailbox damage by the snow plows. She followed up on the call to determine the Village of Oswego was responsible for this area and informed the resident to contact the Village Public Works Department.

Pat Stiles spoke on the position of the Highway Commissioner and the expenses incurred by hiring Novotny Engineering.


Scott Pugsley asked when the public can see closed session minutes. Attorney Keri-Lyn responded that when the Board reviews and releases them, they will be available.
