OSWEGO TOWNSHIP Regular Meeting April 11, 2017

The meeting was called to order at 6:30 p.m. by Supervisor Jim Detzler. The pledge of allegiance to the U.S. flag was given by all in attendance.

Kendall County Deputy Sheriff David Lawson and Oswego Township Residents Bob Rogerson, Jan Alexander, Leah Philpot, Debbie Rogerson, Diane Selmer, Rick Jacobson, Allyson Jacobson, Bill Penley, Tim Pelletier, Amy Pelletier, Jeff Thompson, Diane Cryder, Brian LeClercq, Donna Stanley, Bruce Stanley, Steve Youhanaie, Brian Thomas, Roy White, Russell Boeman, Judith Boeman, Ken Holmstrom, Wm. Prince, Jean Prince, Tim Weszelits, Pat Stiles and Aaron Grosskopf were present. Non Township residents Jim Wyman (WSPY) and Todd Milliron were also present.

Bills in the following funds were presented for approval:

Road and Bridge bills for March in the amount of \$44,261.65 were moved for approval by Bill Small, second by Sid Simmons. A roll call vote was held with Supervisor Detzler and all Trustees present voting "aye" to approve.

Bill Small questioned Highway Commissioner Grosskopf about two concrete bills which were dated in September 2014. Gary Grosskopf told Bill that Bill voted for each of them in 2014, but there is an investigation going on at the present time so no further statement may be made tonight.

Hard Road bills for March in the amount of \$101,163.15 were moved for approval by Sid Simmons, second by Terry Hoch. A roll call vote was held with Supervisor Detzler and all Trustees present voting "aye" to approve.

No Oswego Senior Center report was given.

Deputy Sheriff David Lawson reported on the recent Boulder Hill Neighborhood Watch meeting that was held and well attended.

Highway Commissioner Grosskopf reported that the Highway Dept. Budget was posted on March 31, 2017 and will be voted on during the hearing on May 9, 2017. The Highway Commissioners Annual Report to the Board which will be read at tonight's Annual Meeting agrees with the Supervisors Highway Dept. Report.

Assessor David Maher reported that the new Real Estate Tax Bills will be sent out about May 1, 2017 by the Kendall County Treasurer. Assessor Maher also spoke about the news that Caterpillar Tractor will be moving production from their plant in the Township and how and when this move will affect the assessments here in Oswego Township.

Supervisor Detzler had nothing new to report.

No old business was discussed.

A motion to adjourn this meeting was made by Sid Simmons. A second was made by Terry Hoch. Supervisor Detzler declared the meeting adjourned at 6:45 P.M.
