

Minutes of the Oswego Township

REGULAR MEETING

July 11, 2023

Approved 8-8-23

The meeting of the Oswego Township was called to order at 6:30 P.M by Supervisor Joe West. The meeting was held at 99 Boulder Hill Pass, Montgomery, Illinois. The pledge of allegiance to the U.S flag was given by all in attendance.

Township officials in attendance were Supervisor West, Trustees Bush, Selmer and Helgeson, Clerk Holmstrom, Highway Commissioner Ainsworth. Donna Stanley, Rob Delong and Frank Carney were present. Deputy Sheriff was present. Assessor Hauser was excused from this meeting. Trustee Sawicki was absent. Supervisor West stated that a quorum was present. No other residents were present.

Supervisor West asked if there were any corrections to the Minutes from 6-13-2023. Trustee Helgeson motioned to approve the minutes of 6-13-2023, second by Trustee Bush. Roll call: Trustee Bush, Helgeson, Selmer and Supervisor West motioned to approve.



KCSO Hosts Multi-Jurisdictional Sex Offender Verification Check Initiative

On June 26, 2023, the Kendall County Sheriff's Office hosted an initiative to check compliance on all registered sex offenders and registered violent offenders against youth residing in Kendall County. Investigators from nine (9) police agencies worked together to conduct compliance checks on 96 offenders making contact with 53. As a result of these checks, investigators identified thirteen (13) offenders that were possibly in violation of the Sex Offender Registration Act or the Violent Offender Against Youth Registration Act. Criminal investigations into these allegations are currently being conducted.

As a part of this multi-jurisdictional police initiative, two (2) outstanding arrest warrants were also served.

Rafael Sanchez, a 52-year-old man of the 700 Block of N. Bridge St, Yorkville, IL, was taken into custody on an original warrant charging him with ten (10) counts of predatory criminal sexual assault of a child, each count is a class X felony, and ten (10) counts of criminal sexual assault, each count is a class 1 felony. He is currently in custody at the Kendall County Jail, and his bond has been set at \$500,000, with ten percent to apply.

Kalub Douglas, a 20-year-old man of the 0-99 block of S. Bereman Road, Montgomery, IL, was taken into custody on an original warrant charging him with three (3) counts of aggravated criminal sexual abuse, each count is a class 2 felony. He is currently in custody at the Kendall County Jail, and his bond has been set at \$50,000, with ten percent to apply.

A representative from the Kendall County Sheriff's Office will be attending the Boulder Hill Neighborhood Watch meeting on Wednesday, July 12th @ 7 PM to provide an educational presentation about NARCAN® Nasal Spray. NARCAN® is a potentially lifesaving medication designed to help reverse the effects of an opioid overdose in minutes. The presentation will be to educate the community about NARCAN® and how it is used. We will also have free NARCAN® Rescue Kits available for community members wishing to get one.

Again the meeting is Wednesday, July 12th @ 7 PM and is held at the Oswego Township Office located at 99 Boulder Hill Pass in Montgomery. We hope to see you there!



ORDINANCE REPORT

July 2023

To date I have investigated 83 ordinance complaints which have resulted in 75 violations. Of the violations issued there have been 12 violations for unauthorized trailer or rv parking, 5 inoperable vehicles, 31 junk and debris complaints and 27 tall grass violations. Of the 27 tall grass violations, 7 properties needed to be mowed for non-compliance.
