## Minutes of the Oswego Township

## REGULAR MEETING

January 9, 2024

The meeting of the Oswego Township was called to order at 6:30 P.M by Supervisor Joe West. The meeting was held at 99 Boulder Hill Pass, Montgomery, Illinois. The pledge of allegiance to the U.S flag was given by all in attendance.

Next was discussion and vote to approve Resolution 2024-01, regarding Participation by current Elected Township Official in the Illinois Municipal Retirement Fund. Supervisor West wished to opt out of the retirement plan. Trustee Selmer motioned to approve Resolution 2024-01, second by Trustee Helgeson. Roll call: Trustee Bush, Sawicki, Selmer, Helgeson and Supervisor West voted in favor. Motion carried.

Discussion and vote to approve agreement to retain Mack & Associates for FY 2024 audit services, Trustee Helgeson motioned to approve, second by Trustee Bush. Roll call: Trustee Bush, Helgeson, Sawicki, Selmer and Supervisor West motioned to approve. Motion carried.

Discussion and vote to update the bill approval procedures for the Township. The Board will be approving bills from the first of the month. to the last day of the month. Trustee Helgeson motioned to approve, second by Trustee Bush. Roll Call: Trustee Bush, Helgeson, Sawicki, Selmer and Supervisor West voted in favor. Motion carried.

Discussion and vote to accept Len Wass' resignation from the Oswego Township Plan Commission. Trustee Selmer made the motion second by Trustee Helgeson. Roll call: Trustee Bush, Helgeson, Sawicki, Selmer and Supervisor West motioned to approve. Motion carried.

Discussion and vote to approve Scott Gryder to the Oswego Township Plan Commission. Trustee Sawicki motioned to approve, second by Trustee Selmer. Roll Call: Trustee Bush, Helgeson, Sawicki, Selmer and Supervisor West motion to approve. Motion carried.

Old Business: None

Trustee Selmer motioned to enter into closed session for the discussion of employee's Compensation. Second by Trustee Helgeson. Roll Call: Trustee Bush, Helgeson, Sawicki, Selmer and Supervisor West approved moving to closed session at 7:20 pm.
