An ordinance appropriating for all Road District purposes for
OSWEGO Township Road District, KENDALL County, Illinois, for the fiscal year beginning
APRIL 1, 2025 and ending MARCH 31, 2026.

BE IT ORDAINED by the Board of Trustees of OSWEGO Township,
KENDALL County, Illinois.

SECTION 1: That the amounts hereinafter set forth, or so much thereof as may be authorized
by law, and as may be needed or deemed necessary to defray all expenses and liabilities of
OSWEGO Township Road District, be and the same are hereby appropriated for the
purposes of OSWEGO Township Road District, KENDALL
County, Illinois, as hereinafter specified for the fiscal year beginning
APRIL 1, 2025 and ending MARCH 31, 2026.

SECTION 2: That the following budget containing an estimate of revenues and expenditures

SECTION 4: That if any section, subdivision, or sentence of this ordinance
shall for any reason be held invalid or to be unconstitutional, such decision shall
not affect the validity of the remaining portion of this ordinance.

SECTION 5: That each appropriated fund total shall be divided among the several objects and
purposes specified, and in the particular amounts stated for each fund respectively in Section 2,
constituting the total appropriations in the amount of:


Three Million, Nine Hundred Ninety Five Thousand, Three Hundred and 00/100 (\$3,995,300.00)
for the fiscal year beginning APRIL 1, 2025 and ending MARCH 31, 2026

SECTION 6: That Section 3 shall be and is a summary of the annual Appropriation Ordinance
of this Township Road District, passed by the Board of Trustees as required by law
and shall be in full force and effect from and after this date.

SECTION 7: That a certified copy of the Budget & Appropriation Ordinance shall be filed with
the County Clerk within 30 days after adoption.
